## CHALLENGING ISSUES IN BIOETHICS

Ethical issues impact on medical research and on our everyday lives. This course is an opportunity to think about these issues, guided by experts in their fields (bioethics, law, medicine, epidemiology, philosophy, clinical trial methodology). The topics and case studies have been carefully chosen to give an overview of current issues and to indicate the wide variety relevant to society today. These include how we think about ethics, how we think about illness and disease, looking back at 'the unfortunate experiment' and at progress since then regarding ethics committees, ethical issues when evaluating clinical trials, animal ethics, the difficult question of consent when people are unable to give it, genetics and reproduction, end of life issues and sports medicine.
